The General Insurance Terms and Conditions provide full information about the personal data controller, the purposes of the processing of personal data, the legitimate purposes of the processing of personal data, the categories of recipients of personal data, the transfer of data outside the European Economic Area, the duration of the processing of personal data, the existence of automated decision-making, the right to lodge a complaint with the supervisory authority, the mandatory or voluntary nature of supply of specific items of personal data, the right of access to personal data, the possibility of its correction, deletion or restriction of the processing, or the right to object to the processing, as well as the right to transfer data and the right to withdraw one's consent
